JUDGMENT

Donise Boscareno filed a Rule to Show Cause alleging Louisiana Health Care Consultants, LLC ("LHCC") and Bob G. Dean violated the Louisiana Wage Payment Act, La. R.S. 23:631, *et seq.* The matter came for summary proceeding on February 15, 2022. Defendants were personally served on February 1, 2022 for this hearing.


Considering the pleadings, applicable law, exhibits, evidence, and testimony the Court finds as follows:


IT IS ORDERED ADJUDGED AND DECREED that Louisiana Health Care Consultants, LLC ("LHCC") and Bob G. Dean are in violation of the Louisiana Wage Payment Act ("LWPA"), La. R.S. 23:631, *et seq.*, for their continued refusal to pay Donise Boscareno's 1) owed wages for work performed on October 26, 2021 and October 27, 2021, and 2) ten (10) accrued vacation days, since employment was terminated, and despite demands for payment. The Court further finds there is no good faith justification for the refusal to pay the earned wages.

ACCORDINGLY, IT IS ORDERED ADJUDGED AND DECREED that there be a judgment in favor of Donise Boscareno, and against Louisiana Health Care Consultants, LLC ("LHCC") and Bob G. Dean, *in solido*, in the amount of \$2,164.58 for the work performed on October 26, 2021 and October 27, 2021, \$10,822.78 for (ten days) two weeks of accrued and owed vacation, and an additional \$97,406.10 in statutory penalties; and that Donise Boscareno is further awarded 33 1/3 % in statutory attorney fees.

IT IS FURTHER ORDERED ADJUDGED AND DECREED that Donise Boscareno is awarded judicial interest from the date of demand until paid on all judgment amounts detailed above, and awarded all costs in the matter.
